- "(2) When in bulk
- (a) substances of 1° (a) and (c) and 2° shall be loaded on to specially-fitted covered vehicles equipped with ventilating installations. During the months from November to February, these substances may also be loaded on to open vehicles on condition that they have been sprayed with suitable disinfectants to remove their bad odour;
- (b) the following shall be loaded on to open vehicles:
  - substances of  $1^{\circ}(b)$ , after being sprayed with suitable disinfectants to remove their bad odour;
  - substances of 3°;
  - substances of 5° after being sprayed with limewash so that no putrid odour is discernible;
  - substances of 9°''.
- (3) The first line should read:
- "Moreover, when they are loaded on to open vehicles, they shall be covered with:".
- (4) Delete.

Marginal 210 330 (1) (e) and (f)

Subparagraph (e) should read:

"(e) A tank of a capacity of approximately 30 litres of water shall be provided. This water tank shall be positioned as securely as possible; an antifreeze that will not harm the skin or mucous membranes or cause a chemical reaction with the load shall be added to the water".

The last line of subparagraph (f) should read:

"or of alloy steel not liable to cause decomposition of hydrogen peroxide".

Marginal 210 141 (5)

Replace the first part of the sentence by:

"(5) If the battery vehicle or the battery of receptables mentioned in (3) has been tested at a pressure lower than that indicated under (3) (b), the degre of filling shall be such that . . . etc.".
